

The Murder of Isaiah Hammett

...What We Know So Far

Without announcing themselves the police broke a window, busted down the front door, entered, and unloaded roughly 120 rounds into Isaiah's grandpas house

-The police claim they threw a flash bang, but there was no scorch marks or residual smell

-Police claimed Isaiah fired at them with an AK-47, but the AK-47 which Isaiah legally owned and was registered to him was not functional

- None of the bullet holes in the house were consistent with the rounds that are fired from an AK-47

- The police presented no search warrant until 5 or 6 hours later. When they did, it wasn't sealed. The Department of Internal Affairs later confirmed that the warrant was fake.

-When his family went to view the body at the morgue, the top of his head and under his chin was covered. This lead people to believe that the officers had shot him under his chin in a manner that would not allow an open casket. There was also buckshot found in the ground where Isaiah's body was found, making it seem as if they had shot him while he was down.

-Police sloppily tried to clean his remains from the wall, which were later found by family members

- Isaiah's Grandpa, who is a Vietnam War veteran, had his guns (which were all legal) confiscated by law enforcement. His american flag was also torn down before they entered the house, leaving just a hanging shred of fabric

-The next day the family was served with a notice saying the city would condemn their house if they didn't fix a laundry list of items included the many holes in the walls which were fired by officers.

- We're now trying to raise money for an independent forensic examiner to analyze the scene (\$5000), repairs to the house, and a funeral.
