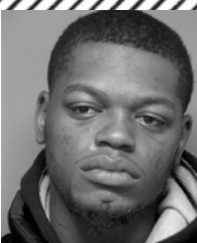

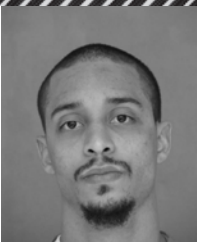

On February 1, 2017, inmates at the James T Vaughn Correctional Center (JTVCC) in Delaware took control of their unit and held staff hostage in an uprising that lasted eighteen hours. They called the media, released a list of demands, and explained their actions as motivated by their conditions of confinement as well as the election of Donald Trump as President. One prison guard, Steven Floyd, was killed by inmates during the uprising.

Sixteen prisoners are now facing first degree murder charges and two others are facing other charges related to the riot. Please take a moment to share your solidarity with those facing repression. Use these addresses to write them letters.
