**We call for the immediate withdrawal of all RCMP
and CGL from sovereign Wet'suwet'en territories**

On Thursday February 6, heavily militarized police (RCMP) began a violent invasion into the unceded territory of the sovereign Wet'suwet'en peoples located within northwestern so-called British Columbia. The RCMP, in a convoy of over 50 vehicles, have been forcibly removing land defenders to pave the way for Coastal GasLink to build a liquefied natural gas pipeline through their territory. The resistance to pipelines through Wet'suwet'en territory has been ongoing: for the past 10 years – Wet'suwet'en people have been reclaiming land stolen from them by the Canadian State by building cabins, checkpoints and a healing center near the corridor of the pipeline.

On January 4th 2020, Hereditary chiefs representing all five clans of the Wet'suwet'en Nation evicted CGL from their unceded territory. For the year prior, CGL had violated Wet'suwet'en law of trespass, occupying their land with industrial man-camps, bulldozing through their territories, and destroying archaeological sites. As tensions escalate, the RCMP are restricting Wet'suwet'en Chiefs, peoples, thier supporters, essential supplies, legal observers and media from accessing the camps. The government of BC is in clear violation of a Supreme court ruling recognizing that the Wet'suwet'en people have never ceded or surrendered their territory. The United Nations has ordered Canada to cease work on the CGL pipeline, as it is in violation of the the UN Declaration of the Rights of Indigenous Peoples.

Since January 4th, hundreds of solidarity actions across Turtle Island have been targeting the federal and BC governments, economic infrastructure, the police and profiteers.
